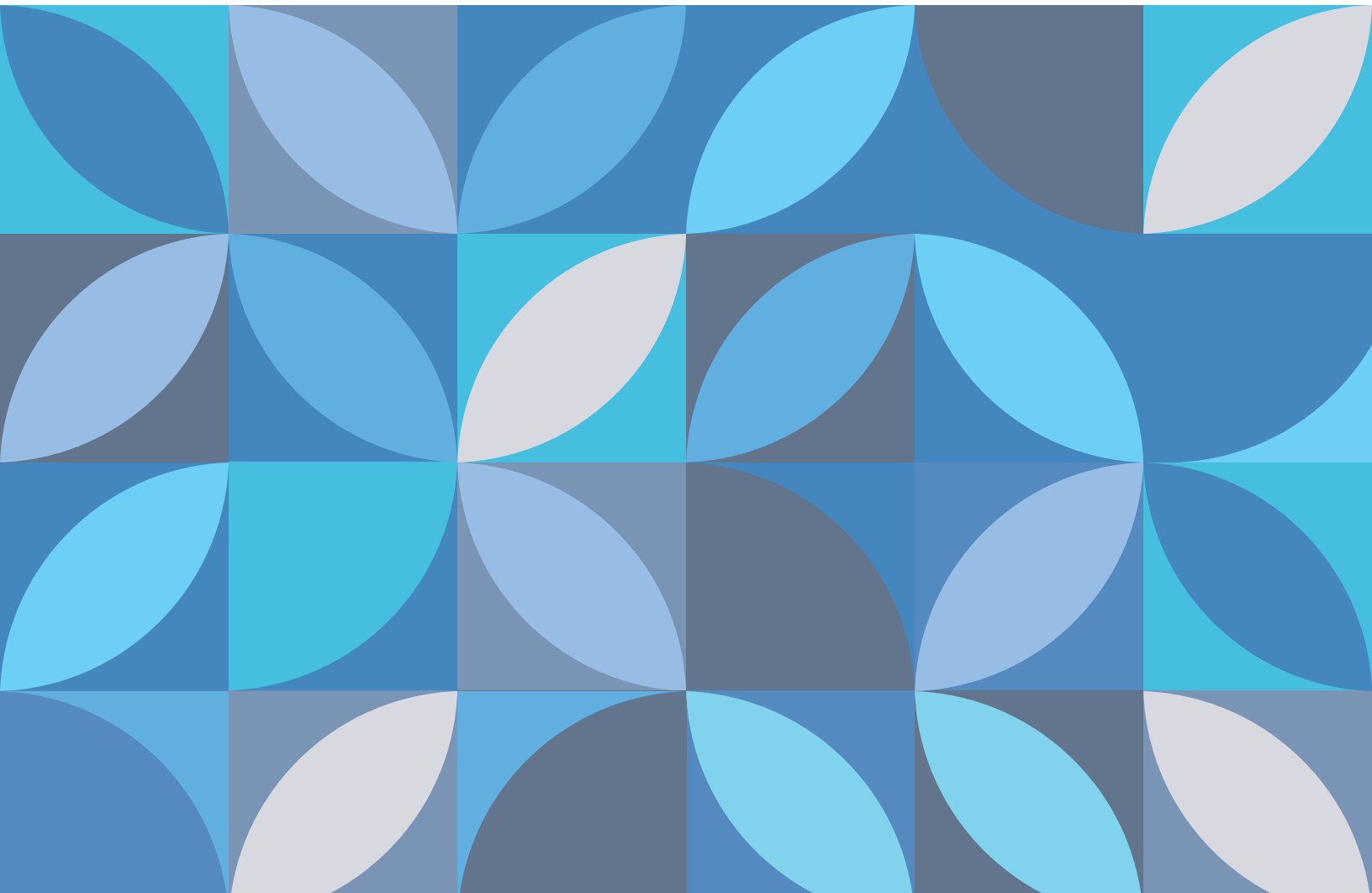
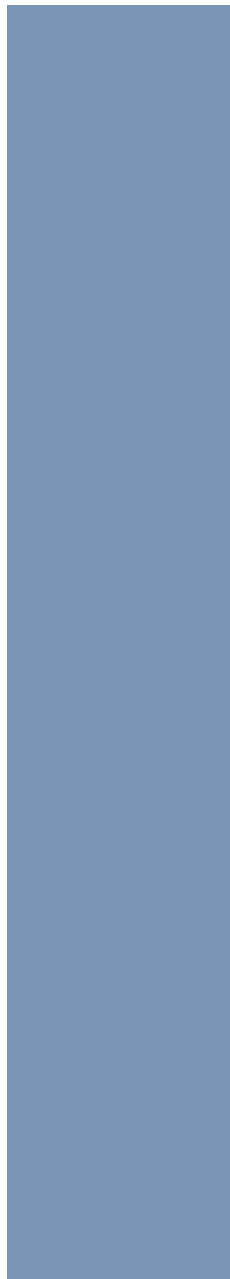

The Greywolf Foundation was started in 2021 by Joe and Denise Wagner to organize and encourage charitable giving by their family and their company, Greywolf Partners, Inc. The couple are long-time, proud residents of Sun Prairie, Wisconsin, where they have raised three children. They enjoy being active in the community through volunteering as well as supporting various charitable causes and community organizations.

2023 Greywolf Foundation Annual Report

As the Greywolf Foundation grows, we are continuously discovering the numerous needs throughout our communities, but also the tremendous number of caring and generous people who want to help. In this light, we are proud of the positive impact of the Greywolf Foundation, as demonstrated by the following highlights from 2023:

- ▶ The Greywolf Foundation increased our charitable giving to nearly \$100,000 in 2023; meaning we will likely surpass a quarter of a million dollars in total charitable giving sometime in 2024.
- ▶ The Greywolf Foundation followed our priority of assisting individuals and groups across a wide spectrum of areas by supporting 52 different local charitable organizations and efforts in 2023. This included 31 new organizations. Many of these outstanding organizations are highlighted in the following pages.
- ▶ The Greywolf Foundation provided resources and collaborated with other entities to have a local impact on the global fight against Alzheimer's and Parkinson's diseases.
- ▶ The Greywolf Foundation continued to collaborate with partners on several grassroots charitable efforts such as donation drives at Honey Creek Corporate Center, a Sunshine Supper, and our Holiday Giving Campaign.

This annual report is a comprehensive narrative of our past year. As we reflect on our past efforts, we are energized to continue making a difference. Habitat for Humanity of Washington & Dodge Counties

Habitat for Humanity of Washington and Dodge Counties is an ecumenical Christian housing ministry creating and maintaining affordable housing through partnerships to positively impact individuals, families, our community, and the environment.

The Greywolf Foundation helped support as well as attended our Annual Celebration Dinner and Auction to help benefit Habitat for Humanity of Washington and Dodge Counties this past March. The annual celebration event helps us raise funds to support our various efforts in the Washington and Dodge Counties throughout the year. The theme of “raise the walls in overalls” event raised more than \$100,000 to assist with home builds and repairs.

Felicia's Donation Closet

Felicia's Donation Closet serves survived women and children from domestic abuse in the Dane County area. The non-profit organization helps women and children prepare themselves for society. Their mission is to create a safe space for domestic abuse survivors and helping them get a hand up in life. Having a safe home helps create the confidence to overcome the challenges in life. Felicia's Donation Closet locates and delivers much needed items for families who are moving from a shelter into their own apartments. They provide the home with necessities such as beds, dressers, kitchen tables, couches, kitchen and bath essentials, TV's, toys, computers, etc.

It cost Felicia's Donation Closet approximately \$1,000 to move a family of four (4) into a new apartment. Donations such as the \$500 from Greywolf Foundation add to our Operating Fund to ensure we can serve as many families as possible. Year-to-date we have helped 98 women and 157 children to move a new home.

Big Brothers Big Sisters of Dane County

Big Brothers Big Sisters of Dane County is a nonprofit that empowers children to reach their full potential by creating and supporting strong and enduring one-on-one mentoring relationships throughout Madison and Dane County. We operate under the belief that inherent in every child is the ability to succeed and thrive in life. BBBS of Dane County fills gaps by providing long-term, consistent mentoring between adult volunteers (Bigs) and children (Littles), ages 6 through 18. The positive relationships we help facilitate throughout Dane County have a direct and lasting effect on the lives of young people.

The Greywolf Foundation's support of Big Brothers Big Sisters' event, THE HUNT, helped us raise over \$90,000 to support the 500+ kids that we served this year. This event had 262 participants, over 700 individual donations and involvement of 35 local businesses. All funds raised during THE HUNT go to our local BBBS programs, where we create and support life-long mentoring relationships. There is no cost for kids to participate in our program so fundraisers like THE HUNT are crucial to maintain existing Matches and create new Matches for the nearly 200 kids on our waitlist.

Our mission extends beyond the stage to the heart of underserved Milwaukee neighborhoods, where we provide comprehensive music residencies. We aim to inspire, create shared experiences, and ensure equitable access to high-quality music education, fostering creativity and enriching lives. Our dedication to performance, audience engagement, and music education aligns with our vision of a culturally vibrant Wisconsin, where every child can dream and thrive.

Greywolf Foundation's invaluable support through a Hometown Sponsorship has been instrumental in transforming the lives of talented young performers associated with the Kids from Wisconsin program. Their generous donation directly contributed to the success of our Hometown KIDS from Madison, enabling them to participate in a professional, Broadway-caliber tour covering 6,000 miles and reaching over 120,000 audience members statewide. The donation specifically assisted in covering essential costs, such as tuition-free professional performing experiences, housing, and transportation, making this unique opportunity accessible to aspiring artists who might not have otherwise had the chance.

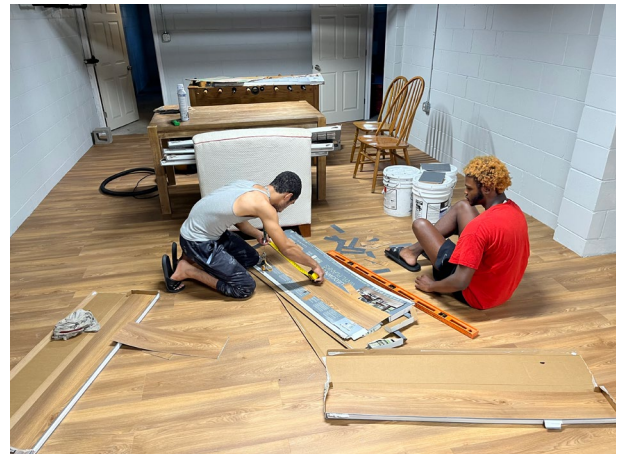

Tri 4 Schools is a nonprofit supporting the wellbeing of kids inside and outside the classroom through multisport events, afterschool programs, financial assistance, and grants for schools.

Tri 4 Schools Training Team programs are 8–10-week afterschool programs that use swim, bike, and run to teach kids important life skills like goal setting, teamwork, perseverance, and confidence. One of the most loved parts of the program is the biking unit. Tri 4 Schools is committed to providing every child with the opportunity to be active in a safe environment, which is why we have a no-questions-asked financial assistance policy. We provide scholarships and equipment to disadvantaged children, ensuring that everyone can participate. The Greywolf Foundation’s donation supports the maintenance of our bike trailer. Each year, the bikes are used thousands of times by children who would not know the freedom of biking otherwise.

Oppose Alzheimer's Initiative

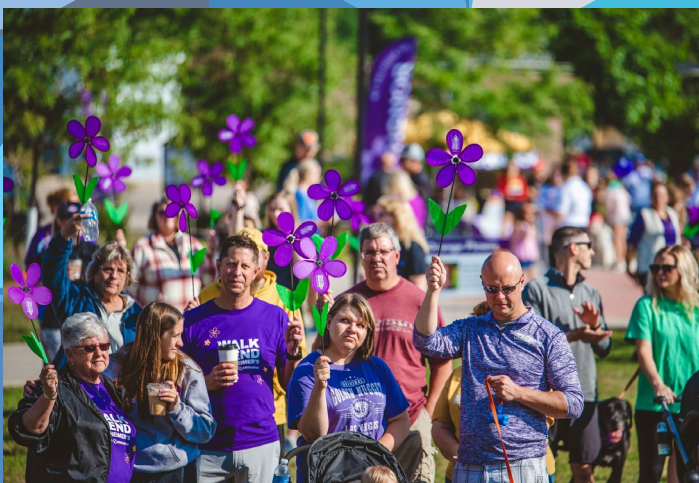
Greywolf Foundation & Park Vista Senior Housing Management

A collaborative effort between Park Vista Senior Housing Management (PVSHM) and the Greywolf Foundation helps to raise awareness of the challenges related with Alzheimer's disease and associated dementia while also raise funds for the treatment, care and research opportunities which are combating this disease.

To date, this initiative has raised and donated over \$52,000 to the Alzheimer's Association Wisconsin Chapter. This includes nearly \$18,000 in 2023, which was raised via a variety of methods:

- Sponsorships of Walk To End Alzheimer's (WTEA) held during September and October in the communities of Waukesha County, Stevens Point, Washington County, Milwaukee County, Kenosha/Racine, Rock County, Fox Cities and Dane County.
- Fundraising teams formed by PVSHM staff to participate and support many of the sponsored WTEA events.
- BB Jack's Cottage Grove's Pizza with a Purpose program for the month of August 2023.
- Staff, residents, family and friends from five different PVSHM facilities raising money and awareness of the Oppose Alzheimer's Initiative through various activities throughout the year.

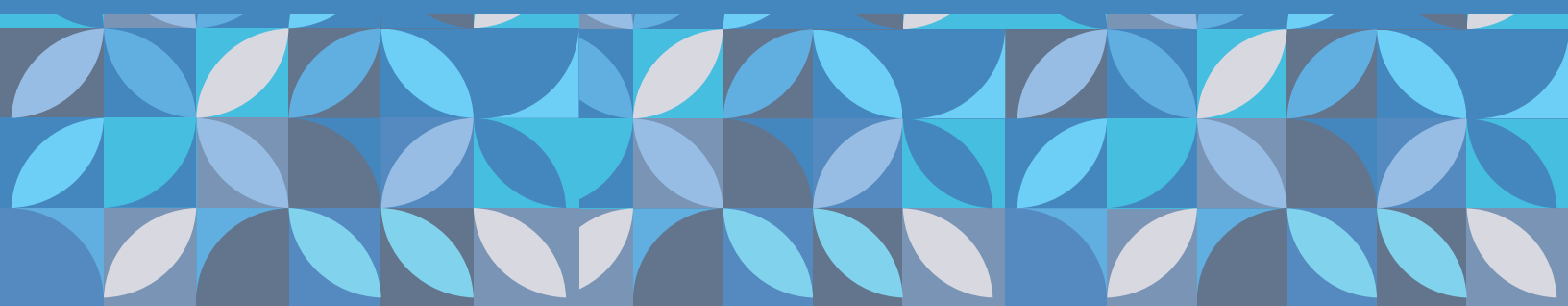
The Bob & Melida Wagner Scholarships

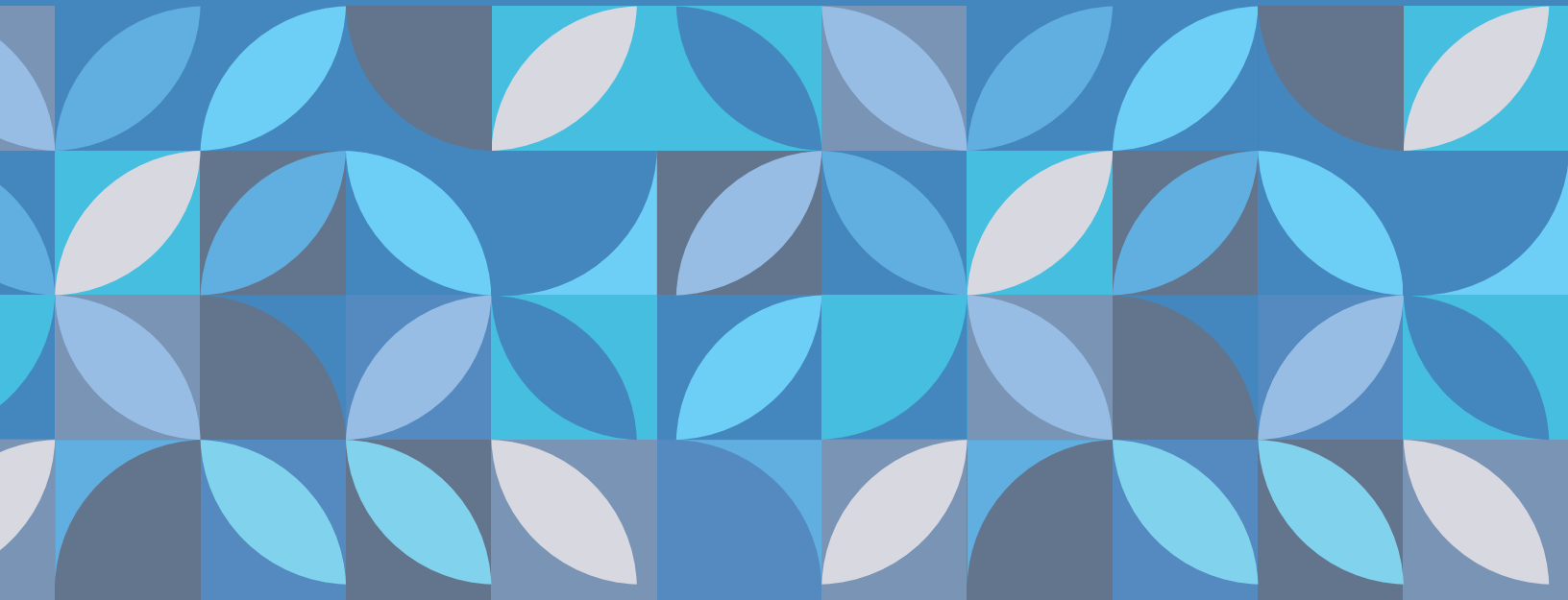

The Greywolf Foundation and Greywolf Partners are committed to the caring and welfare of all its employees. The Greywolf Foundation Employee Assistance Fund (GEAF) was created in 2022 to help support employees of Greywolf Partners and its associated entities in times of extreme hardship. Sunshine Supper

Sunshine Place is a resource for food, clothing, and other services to residents in need in Sun Prairie and Northeastern Dane County. The Greywolf Foundation provided the food for a Sunshine Supper in October 2023. Over 450 meals were served in less than an hour by volunteers from Greywolf Partners and Sunshine Place. The delicious dinner of barbeque chicken, garlic mashed potatoes, corn, and a dinner roll was prepared by the kitchen staff at BB Jack's Cottage Grove.





Holiday Giving

The Greywolf Foundation partnered with employees of both Greywolf Partners and Park Vista Senior Housing Management to have create some cheer and assist others during the Holidays. Money was collected to support Holiday events at all eight of Park Vista's properties, which included providing treats such as hot chocolate, eggnog, cookies, candy bags, etc.

Greywolf Partners employees also contributed to purchase gift cards to Target and Pick 'N Save to assist six young men in the Bridge To Brighter program. Bridge To Brighter assists young men in the Milwaukee area who age out of the foster care system at 18 years old and must adjust to handling living, employment, and education/training realities on their own.

The Greywolf Foundation is also proud to acknowledge the incredible efforts of Greywolf Partners team members Marilyn Herzberg and Becky Hughes during the Holiday season. These two ladies, along with their friends Nancy Hermsen and Tina Salear, sewed 50 stunning quilts that were given to the residents at The Legacy of Deforest.
